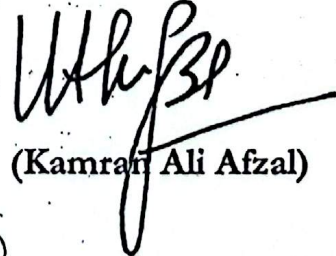
Dear Colleagues,

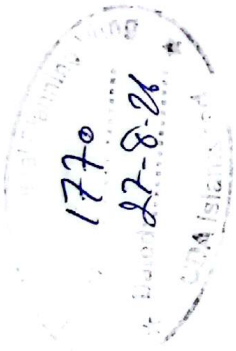
